CONTRACT FOR PROCESSING MEAT

This Agreement is made between Reasons Inc., d/b/a Reason's Locker Service or Reason's Prairie Pride Meats, hereinafter "Processor" and "Customer".

Chronic Wasting Disease (CWD) has been detected in deer and elk in several states. This establishment will not knowingly accept any game animal suspected of having CWD or showing symptoms of it and will report any suspect animals to the proper authorities.

We provide a custom processing service for your game animals and take the highest precautions in safety and sanitation of our facilities and equipment. We cannot guarantee that any animal brought in for processing does or does not have CWD. That testing may be done by game agency officials or by sportsmen, but cannot be done in this facility. We cannot assume responsibility for animal testing or failure to test for CWD.

1. The parties agree that this agreement shall apply to all orders placed by Customer through Processor for the processing of any animals or meat products. It is anticipated that each time Customer requests processing by Processor, a work order shall be prepared. Regardless of whether such work order references this Agreement, all work orders shall be deemed to be governed by the terms of this Agreement.
2. Processor shall perform its services in processing the animal meat products of Customer using ordinary care consistent with industry standards for processing meat and meat products under such circumstances. The parties agree that such processing activities are only for Customer's own use and Customer desires that Processor only perform those activities requested in order to make sure that such processing is done in a cost effective manner. Specifically, the parties agree that Processor shall not conduct any testing of meat which has been placed with Processor by Customer for processing. Although Processor will follow normal and reasonable industry standards to prevent Processor from creating any health hazards by virtue of Processor activities, Processor is not responsible for determining whether or not the meat given to Processor by Customer is free from health hazards. Specifically, the parties acknowledge that if sausage is requested to be prepared by Processor, such sausage is not guaranteed to be separated from exposure to similar products of other Customers. Requests for sausage made from Customer's own meat require a minimum of 70 lbs boneless meat per sausage item and will be done after other orders are processed which could take up to 3-4 months return time depending on time of year and number of orders to be processed by Processor.
3. A \$50 deposit is required at time of dropping off whole deer (no deposit required for boneless meat), which will be applied as a credit to processing invoice when invoice is paid in full. Payment can be made by cash, check, or credit card (VISA, MASTERCARD) and must be paid before deer can be processed. If \$50 deposit is not paid after 3 days, Processor is no longer responsible for disposition of deer and deer carcass will be disposed of. Payment shall be due by Customer upon completion of work at or before delivery by Processor to Customer. In the event that Customer fails to pay when due, Processor may withhold such products from delivery to Customer or pursue any other remedy. If Customer fails to pay when due, there will be a 5% late fee to cover the additional inconvenience to Processor and interest shall accrue at the rate of 1% per month for any month or portion thereof until payment is made. In addition, Customer shall be liable for reasonable attorney fees and other collection costs incurred by Processor in enforcing the terms hereof.
4. When processing order is complete Processor will notify Customer to pick up order. After first notification, the Customer has two weeks to pick up order. If Customer is unable to pick up order after 2 weeks, a fee of \$10 per week will be assessed for storage.
